WHAT IS

INDEPENDENT LIVE?

Independent live entertainment stages are independently owned and operated, meaning they are not controlled by a multinational corporation or a publicly traded company, and their primary mission is to present live performances to the public. This includes venues, promoters, festivals and more.

OVERVIEW IN

MISSOURI

Missouri's independent live entertainment industry drives \$1.2 billion in state GDP, \$2.3 billion in economic output, and \$147.6 in tax revenue, supporting 16,461 jobs and \$692.9 million in wages. With \$157.4 million in off-site tourism spending, the sector is both a cultural anchor and a major economic force.
