# INDEPENDENT LIVE?

Independent live entertainment stages are independently owned and operated, meaning they are not controlled by a multinational corporation or a publicly traded company, and their primary mission is to present live performances to the public. This includes venues, promoters, festivals and more.

# NEVADA

Nevada's independent live entertainment industry drives \$1.9 billion in state GDP, \$3 billion in economic output, and \$151.4 million in tax revenue, supporting 16,095 jobs and \$858.8 million in wages. With \$309.3 million in off-site tourism spending, the sector is both a cultural anchor and a major economic force.

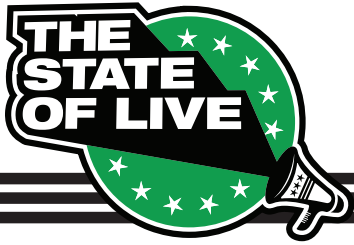
